

**Network Associates PGPsdm End User License Agreement**  
(For Non-Commercial Use and Limited Commercial Use and Distribution )

NOTICE TO ALL USERS: CAREFULLY READ THE FOLLOWING LEGAL AGREEMENT ("AGREEMENT"), FOR THE LICENSE OF SPECIFIED SOFTWARE ("TOOLKIT SOFTWARE") BY NETWORK ASSOCIATES, INC. ("NETWORK ASSOCIATES"). BY CLICKING THE ACCEPT BUTTON OR INSTALLING THE TOOLKIT SOFTWARE, YOU (EITHER AN INDIVIDUAL OR A SINGLE ENTITY) CONSENT TO BE BOUND BY AND BECOME A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE BUTTON THAT INDICATES THAT YOU DO NOT ACCEPT THE TERMS OF THIS AGREEMENT AND DO NOT INSTALL THE TOOLKIT SOFTWARE. (IF APPLICABLE, YOU MAY RETURN THE PRODUCT TO THE PLACE OF PURCHASE FOR A FULL REFUND.)

Network Associates is permitting the (a) the non-commercial use of this Toolkit Software, (b) the non-commercial use of the Toolkit Software and the distribution of a separate non-commercial software application ("Non-Commercial Software") into which the Toolkit Software is incorporated, within the scope of the following license, and (c) the limited commercial use and distribution of a separate commercial software application ("Commercial Software") into which the Toolkit Software is incorporated, within the scope of the following license, provided that You agree to pay Network Associates a fee relating to the sale of the Commercial Software in the form of either i) royalty fees of one (1) dollar per copy of the Commercial Software distributed or sold, or ii) a fee of six (6) percent of the gross undiscounted sales price of the Commercial Software distributed or sold, whichever is greater. US per year, and provided that all of the terms and conditions set forth below are complied with, You must obtain permission for further distribution and use of the Commercial Software under a separate written OEM agreement with Network Associates. **1. License Grant.** Network Associates grants You (the original end-user and any subsequent transferee of the Toolkit Software as permitted below) a non-exclusive license to put in use by a person or organization that agrees to be bound by the terms of this Agreement, one copy of the Toolkit Software, in the manner set forth below.

- a. Installation. You may install one copy of the Toolkit Software on a single computer or workstation ("Developer Device") for software development purposes. An end user or developer who uses the Toolkit Software for development purposes shall be referred to as a "Developer Seat." You must acquire and dedicate a PGPsdm Software License for each separate Developer Seat who will have access to the Toolkit Software for development purposes. Notwithstanding the foregoing, if You obtained the Toolkit Software on a CD and the CD contains several copies of the Toolkit Software, each of which is compatible with a different operating system or platform architecture (such as Windows95/NT, Macintosh, one or more versions of Unix, or other architectures), then You may install the Toolkit Software on separate Developer Devices for use with one or more of those architectures, provided that those Developer Devices are part of one Developer Seat (i.e., used by a single developer). You may also make a reasonable number of copies of the Toolkit Software solely for backup or archival purposes. Further, if the Toolkit Software is permanently installed on the hard disk or other storage device of a Developer Device (other than a network server) and a single person uses that computer more than 80% of the time it is in use, then that person may also install and use the Toolkit Software on a portable or home computer for development purposes.
- b. Developmental Use. This license authorizes a single Developer Seat to use the Toolkit Software on any Developer Device on which it was properly installed under subsection 1(a) above for the non-commercial purposes set forth in this Section 1. You may not modify the Toolkit Software, or any component thereof, and You may not make copies of or distribute the Toolkit Software, or any component thereof, for use on any computer or workstation other than the authorized Developer Device, except as specifically set forth in this Section 1 without a separate written agreement signed by an authorized officer of Network Associates, or its authorized designee.

- c. Definitions. The term "Developer's Computer Program" shall mean a computer program developed by or for You, published under Your name, or under the name of Your organization, into which the Toolkit Software, or any portion thereof, shall be incorporated or embedded to create Non-Commercial or Commercial Software applications of the Toolkit Software . The Non-Commercial or Commercial Software" shall mean a Developer's Computer Program into which any portion of the Toolkit Software has been incorporated or embedded, provided that the Non-Commercial or Commercial Software (a) is distributed and used for non-commercial purposes or limited commercial purposes and (b) shall represent a significant functional and value enhancement to the Toolkit Software such that the primary reason for an end user to license or use such Non-Commercial or Commercial Software is other than the encryption/decryption or signatures/authentication of data and other than the right to receive a license to use the Toolkit Software included in the Non-Commercial or Commercial Software. Without limiting the generality of the foregoing, the Non-Commercial or Commercial Software may not be a stand alone or add-on data security application or otherwise directly compete with Network Associates products or the Toolkit Software. For purposes hereof, the term "non-commercial" shall mean that the application (a) has been distributed or otherwise made available at no charge (direct or indirect) and (b) is not used for any commercial purpose, which includes, but is not limited to, any activity engaged for the purpose of generating revenues (directly or indirectly). - d. Non-Commercial/Limited Commercial Distribution License. Subject to all the terms and conditions of this Agreement, Network Associates hereby grants to You a limited, nonexclusive, nontransferable license (a) to incorporate the exact, unmodified copies of the Toolkit Software, or a portion thereof, into a Developer's Computer Program to create a Non-Commercial or Commercial Software application, and (b) to reproduce and distribute the Non-Commercial or Commercial Software to end users solely by electronic means (for example, posting on networks or Internet sites for others to download), subject to the following (i) that such distribution is solely for non-commercial purposes, or limited commercial purposes subject to the payment of fees as detailed in the introductory paragraphs above(see requirements of \$1 per copy royalty or fee of 6% of gross revenue of Commercial Software, whichever is greater), (ii) that You do not remove any proprietary rights notices that may be contained in the Toolkit Software, (iii) that You comply with all of the terms and conditions of this Agreement (including, but not limited to, the other conditions set forth in subsection 1(e) below), and (iv) that such distribution may occur anywhere in the world, except that Network Associates expressly forbids the export of the Toolkit Software, or any portion thereof, to any countries embargoed by the U.S. government (currently including, Cuba, Iran, Iraq, Libya, North Korea, Syria and Sudan).
- e. Other Conditions. Each copy of any Freeware Derivative work developed hereunder shall contain the following notice placed conspicuously in the "splash screen" and "about box," if any, and wherever else a copyright or other proprietary rights notice appears in the Freeware Derivative work software and documentation thereto:

You may not access the Toolkit Software through any way other than the interface published by Network Associates in the end user documentation for the Toolkit Software. The only portions of the Toolkit Software which may be incorporated or embedded into a Non-Commercial or Commercial Software are those portions of the Toolkit Software which constitute binary files that can be executed on a computer (and not text files, such as "header" or "source" files). Use of the Toolkit Software, or components thereof, in Server-Based Non-Commercial or Commercial Software is permitted for both non-commercial purposes and the limited commercial purposes provided the terms and conditions of this license are followed. You may not copy the Toolkit Software or Documentation except as expressly permitted in Section 1 above. You may not remove any proprietary notices or labels on the Toolkit Software. All rights not expressly set forth hereunder are reserved by Network Associates. Network Associates reserves the right to periodically conduct audits upon advance written notice to verify Your compliance with the terms of this Agreement.
3. **Term.** This Agreement is effective unless and until earlier terminated as set forth herein. This Agreement will terminate automatically if You fail to comply with any of the limitations or other requirements described herein. Upon any termination or expiration of this Agreement, You must destroy all copies of the Toolkit Software and the Documentation. You may terminate this Agreement at any point by destroying all copies of the Toolkit Software and the Documentation.
4. **Updates.** Network Associates does not offer technical support for the Toolkit Software, however, Network Associates welcomes Your feedback. 5. **Ownership Rights.** The Toolkit Software is protected by United States copyright laws and international treaty provisions. Network Associates and its suppliers own and retain all right, title and interest in and to the Toolkit Software, including all copyrights, patents, trade secret rights, trademarks and other intellectual property rights therein. Your possession, installation, or use of the Toolkit Software does not transfer to You any title to the intellectual property in the Toolkit Software, and You will not acquire any rights to the Toolkit Software except as expressly set forth in this Agreement. All copies of the Toolkit Software and Documentation made hereunder must contain the same proprietary notices that appear on and in the Toolkit Software and Documentation.
6. **Warranty Disclaimer** Because the Toolkit Software is provided to You at no cost, THE TOOLKIT SOFTWARE IS PROVIDED "AS IS." TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, NETWORK ASSOCIATES DISCLAIMS ALL WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT WITH RESPECT TO THE TOOLKIT SOFTWARE AND THE

ACCOMPANYING DOCUMENTATION. YOU ASSUME RESPONSIBILITY FOR SELECTING THE TOOLKIT SOFTWARE TO ACHIEVE YOUR INTENDED RESULTS, AND FOR THE INSTALLATION OF, USE OF, AND RESULTS OBTAINED FROM THE TOOLKIT SOFTWARE. 8. **United States Government.** The Toolkit Software and accompanying Documentation are deemed to be “commercial computer software” and “commercial computer software documentation,” respectively, pursuant to DFAR Section 227.7202 and FAR Section 12.212, as applicable. Any use, modification, reproduction, release, performance, display or disclosure of the Toolkit Software and accompanying Documentation by the United States Government shall be governed solely by the terms of this Agreement and shall be prohibited except to the extent expressly permitted by the terms of this Agreement.
9. **Export Controls.** Neither the Toolkit Software, the Non-Commercial or Commercial Software applications, nor the Documentation and underlying information or technology may be downloaded or otherwise exported or re-exported (i) into (or to a national or resident of) Cuba, Iran, Iraq, Libya, North Korea, Sudan, Syria or any other country to which the United States has embargoed goods; or (ii) to anyone on the United States Treasury Department’s list of Specially Designated Nations or the United States Commerce Department’s Table of Denial Orders. By downloading or using the Toolkit Software You are agreeing to the foregoing and You are certifying that You are not located in, under the control of, or a national or resident of any such country or on any such list.

No provision hereof shall be deemed waived unless such waiver shall be in writing and signed by Network Associates or a duly authorized representative of Network Associates. If any provision of this Agreement is held invalid, the remainder of this Agreement shall continue in full force and effect. The parties confirm that it is their wish that this Agreement has been written in the English language only.
